KINGDOM COMMUNITY BANK – PRIZE DRAW 2020 TERMS AND CONDITIONS

1. Definitions

- **1.1. KCB** shall mean Kingdom Community Bank, a trading name of the organisation detailed in clause 8.1.
- **1.2.** (the) Prize shall be as detailed in clause 3.
- **1.3.** (the) Prize Draw shall mean the Prize Draw conducted under these Terms and Conditions.

2. Eligibility

- **2.1.** Entry into the Prize Draw is open to any person who (as at 1700 on Wednesday 12 March 2020) is:
 - **2.1.1.** aged 18 or over; **and**
 - **2.1.2.** a fully registered, qualifying member of KCB.

4. Entering the draw

- **4.1.** Any eligible individual who provides updated contact details to KCB through www.kingdcomcb.org.uk/mydetails between 0900 on Friday 13 March 2020 and 1700 on Saturday 30 May 2020 shall automatically be entered into the Prize Draw. Entries received outside of this timeframe will not be considered.
- **4.2.** Only one entry per person will be accepted, and joint submissions are not permitted.
- **4.3.** KCB accepts no responsibility for entries that are lost, mislaid, damaged or delayed in transit, regardless of cause, including, for example, as a result of any equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind.
- **4.4.** Proof of submission is not proof of receipt by KCB, and therefore not proof of entry.

- **5.2.** The winner will be notified by telephone on or before 30 June 2020.
- **5.3.** If the winner does not respond to KCB within 14 days of being notified, then the winner's Prize is forfeited, and KCB shall be entitled to select another winner in accordance with

- the process described above. Any alternate winner(s) shall be subject to the same notification requirements.

By entering the Prize Draw, you agree to the collection, retention, usage and distribution of your personal information in order to process and contact you about your Prize Draw entry, and for the purposes outlined in clause 5.7 as well as the uses outlines under the privacy statement which largely relate to you being a Member of KCB and us operating your accounts with us.
- **7.2.** The decision of KCB in all matters under its control is final and binding and no correspondence will be entered into.
- **7.3.** The Prize Draw will be governed by Scots law and entrants to the Prize Draw submit to the exclusive jurisdiction of the Scottish courts.
